## **COMMUNITY UPDATE – ENTRY TO APY LANDS**

11 April 2022

The Anangu Pitjantjatjara Yankunytjatjara Executive Board of Management has reviewed entry requirements to the APY Lands in light of the ongoing threat COVID-19 poses to vulnerable communities.

## The Board resolved to ease restrictions effective Monday, 11 April 2022.

The following entry requirements remain:

- You must be fully vaccinated with two doses. Strictly No Jab, No Entry. Evidence of your vaccination status must be from myGov
- APY Permit application form or notification if applicable
- National Police Check or Working with Children Check
- APY Individual or Organisation Risk Assessment form
- APY Health Record form 72 hours before entering the APY Lands
- People working in high-risk settings (aged care and clinics) who are likely to be in close contact with vulnerable people require evidence of a Polymerase Chain Reaction (PCR) negative COVID-19 test result 72 hours before entry to the APY Lands
- Everyone must wear a mask for seven days in all public spaces on the APY Lands after entry
- Complete a RAT test (TGA approved) one day before entry and on days three and seven and register your results using this <u>online form</u>.

If you don't have a mobile phone with internet access, you can report your result by calling the SA COVID-19 Information Line on 1800 253 787.

You can also report negative and invalid test results using the <u>online form</u> to help provide a full picture of rates of COVID-19 testing in the state.

APY Permits will assess applications with all the relevant required documentation within 10 to 14 days. Please remember that APY is a small team with a large area of land to supervise. Be patient.

If you have tested positive to COVID-19 you cannot enter the APY Lands unless you have been cleared to do so by a COVID GP Assessment Team doctor where you have been under their care; or you have been cleared by a COVID hospital medical team if hospitalised. A clearance certificate/letter is required to be sent to APY Permits.

You must get tested if you:

- Show any COVID-19 symptoms, even if they are mild
- Are a close contact of someone who has COVID-19
- Have been directed by SA Health or SAPOL.
